2009 Wet Wednesday Entry Form – Season and Single Race Fee \$90 Series, \$10 Single Paid _____

Please read this entry form carefully. If you do not abide by its terms please don't sign it and don't enter the Anacapa Yacht Club Wet Wednesday Races.

This form and the rules set forth are for the protection of both the Races and Anacapa Yacht Club **Please read it.**

- This form must be signed by all participants.** Boat slippers may race in one race if they inform the Race Committee that they will sign the entry form after the race. All skippers who have raced in at least one Wet Wednesday and who have NOT signed this form will be disallowed from entering any other race and will not be scored as having entered the race. Violators who still race and have not signed this form may be reported to the Harbor Patrol.
- The form is good for the entire year in which it was signed.** In other words, it need only be signed once for the entire summer.
- All boats must have current liability insurance for their boat.** This insurance must be in force for every race entered. The undersigned slipper verifies that his vessel has liability insurance and that he will not race in Wet Wednesday Races in the event his/her insurance is no longer in effect.
- All boats must have a working engine.** This engine must be capable of propelling their boat at a reasonable rate of speed. In other words, a 1.5 hp engine on a boat over 20 ft. in length does not qualify as a working engine. If you don't have a working engine don't race.
- The undersigned agrees to conform with the rules and regulations** of the Anacapa Yacht Club as set out in the "Anacapa Yacht Club Wet Wednesday Rules and Course Chart" brochure and as may be amended by Anacapa Yacht Club by written notice; the rules, regulations and directions of the Harbor department of the County of Ventura and its Harbor Patrol; all safety requirements of the federal and State agencies; and all other applicable rules and regulations regarding the operation of a recreational vessel in the State of California.
- I certify that I am able to swim** and that no crew member will be allowed to participate unless able to swim and that my boat has **all required safety equipment on board.**
- I acknowledge that I am entering this series of races at my own risk and agree to waive all claims that might arise against the Anacapa Yacht Club, its servants, agents or employees as well as its officers, directors, committee people or club members and agree to hold harmless the foregoing for any liability whatsoever for any accident or injury to myself, my boat or my crew or any guest on my boat while on the water before, during or after any race.
- This entry form is binding on all skippers and drivers of my boat, whether I am on the boat or not I have read all of the above and agree to all the conditions set out. **The boat owner must sign.**
